### (a) Applications

Members considered the following applications for planning permission submitted to South Cambridgeshire District Council as a result of which it was **RESOLVED** 

 i) <u>S/0886/14/FL</u> Temporary to semi-permanent building to be used as additional warehousing space. The Source, Convent Drive, Waterbeach, Cambridge, Cambridgeshire, CB25 9QT

This application was declined at the last meeting due to concerns regarding car parking spaces. However, a member of the company attended the meeting and explained that the area in question is normally used for storage/lorries and so did not impinge on car parking. The company currently do not fill all their parking spaces on a daily basis.
