- Parking in the front of the proposed shop would cause traffic problems, particularly to the adjacent bus stop.

14/95 WATERBEACH POST OFFICE

Cllr Bull left the room for this item as she had declared a Members Interest. The Chair was taken by Cllr J Rabbett for this item.

A discussion took place on the proposed relocation of Waterbeach Post Office from its current premises to a new location within the village stores. Questions were raised that the same level of service would be provided from the new location and the opening hours would remain the same. Concerns were also raised on the impact on the elderly having to cross the road to access the new premises. Cllr P Johnson confirmed that a meeting was taking place on Monday 27 April, to move forward with the new crossing, which should alleviate some of the safety concerns for accessing the Post Office.

The meeting felt that there were still a number of unanswered questions relating to this proposal so have referred the item back to the next Parish Council Meeting on Tuesday 5 May.

Cllr Bull returned to the meeting and Cllr Rabbett handed back the Chair to Cllr Bull.
