A discussion took place on the document which the Council had received between SCDC and Morris Homes (Midlands) Ltd in relation to the planning obligations made under the provisions of Section 106 of the Town and Country Planning Act 1990 (as amended). The meeting felt that S106 agreement had gone ahead with no consultation with the Parish Council and despite attempts by the Clerk to contact SCDC a strongly worded letter should now be sent to Cllr Robert Turner, Planning Portfolio Holder, and copied to other relevant members of Planning at SCDC along with the lawyer dealing with the agreement.

The letter should lay out the following concerns of the Council:

- The Council has been ignored during the creation of this agreement
- The Council had been promised that it would be consulted on all planning related matters going forward
- Under recent planning training by Parish Councillors they understood that under the Town & Country Planning Act 1990 any interested party can be written into a S106 agreement, including Parish and Town Councils.
- Waterbeach Parish Council would like the consultation period to be extended to allow the Council to have an input into the agreement.

The Clerk will be requested to write the letter on behalf of the Planning Committee.
