# ii) S/3033/15/FL Replacement and re-siting of detached garage with office / guest bedroom above

61, Rosemary Road, Waterbeach, Cambridge, Cambridgeshire, CB25 9NB

The Parish Council objects to this planning application and recommends refusal due to over-development along this road and concerns that the build is too close to the road (narrow country lane) especially as the proposal is for a two storey building. Concerns were raised of added traffic problems on Burgess Road with visitors to the office or guests parking on the road. If permission is granted, Waterbeach Parish Council requests a condition be imposed that the guest accommodation not be used as a permanent residence of any kind.
