### i) S/1695/16/FL

Demolition of existing buildings. Provision of 20 apartments and food store.

Welfare Office and Community Building, Capper Road, Waterbeach, CB25 9LY

## The Parish Council RESOLVED to recommend Refusal.

If allowed the PC feels that conditions should be imposed for the period of construction – particularly due to the proximity of the day nursery. Usual conditions for all vehicles and materials to be kept onsite during construction and limits on hours of working.

Comments: The Design and Access statement refers to good bus services in the village which is not the case. The PC feels that the shop is a good idea but has significant concerns about the flats, in terms of the height of the building, the relatively small number of parking spaces planned (18 spaces in total for 20 flats and the shop) and no mention of any affordable housing. If such a development is to be allowed, there should be some benefit to local young people. There should be at least 40 parking spaces for 20 flats and parking spaces should not be shared between the shop and residents. Also the fact that the development will be very close to and overlooking the adjacent children's nursery is a serious concern.

Usual conditions of off road vehicle and materials to be requested.
