i) <u>S/2177/16/FL</u> Erection of 18 dwellings including affordable dwellings, a local play area, internal road, associated alterations to highway and pedestrian access, and modifications to junction arrangements

Land off Gibson Close, Gibson Close, Waterbeach, CB 25 9HY

Enterprise Property Group Ltd

The Council **OBJECTS** to this planning application on the following grounds:

- 1. The Council concurs with the comments of the Planning Consultation Response from South and City Highways.
- 2. Concerns were raised on traffic issues with the relocation of the village pharmacy close to the junction of Gibson Close which will bring an increase in vehicles and people trying to park, and use the pharmacy in an already heavily congested area. There is also the problem with deliveries for the pharmacy which has very limited parking. These issues have already impacted heavily on the Disabled Access for the pharmacy.
- 3. The Bus Stop opposite Gibson Close also adds traffic congestion when buses are parked to pick and drop off passengers.
- 4. Drainage in the area off Gibson Close is already a problem due to high water levels and the proposed plans to raise the ground level by 1 meter will have serious impact on the neighbouring properties, and the surrounding land. The Consultant's report stated that soak- away's were not a viable strategy so by raising the ground level you will still be faced with the same issues of where the water can go.
- 5. A protected tree on the plans appears to show that its root system will be concreted over.

6. 1 Greenside already experiences flooding in its cellar and the road regularly floods outside it on the junction of Chapel Street, Greenside and Gibson Close. The nearby property of Muff's Cottage sits 2 feet below ground level, with the addition of further run-off rain water with nowhere to go this will only increase an already problem area.
